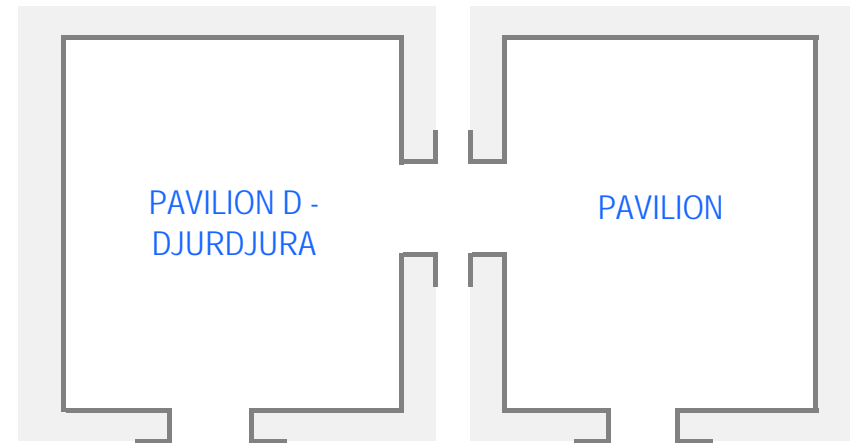

BOOTH CONSTRUCTION GUIDELINES

1. Constructed display material and signage may not be installed higher than 8' except against exterior walls of the building or in island booths as noted on the Floor Plan.
2. No construction display material (booth equipment) may be placed at the sides of booths which will obstruct the view of a neighbor's exhibit.
3. No constructed display material higher than 42" may be placed in the front half of the booth.
4. No booth may be entirely enclosed.
